Many lessons learned for them and a wonderful donation to their community!

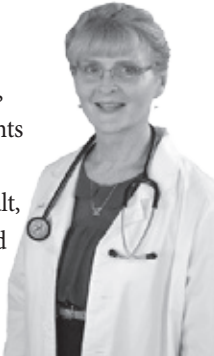
