What Have I Gotten Myself Into?

To the editor:

With the 2014-2015 school year now behind us, my attention has shifted to the 2015-2016 school year ahead. I am extremely excited about my new role as a community representative on the Souhegan High School (SHS) Community Council and have been learning all I can in preparation.

A recent round of letters to the editor and Facebook chatter regarding SHS dimmed my enthusiasm a bit as I wondered if I had been sold a bill of goods. Was I ratcheting up my involvement in a fiscally irresponsible institution coasting on faded glory and outdated dreams? In other words, what have I gotten myself into?

With lots of numbers and opinions swirling around regarding what the Souhegan School Board and administration were (or were not) doing regarding SHS, I realized I needed to put my journalism degree to work and directly ferret out some facts. Just like all of you, I pay my taxes and deserve to know what I'm getting for them!

Good news. The sky is not actually falling. We've got some very dedicated people working to serve our community and students. Contrary to recent allegations, both the school board and district indeed have a long-term plan for improvement in many areas. All of my questions were thoughtfully answered in a timely manner and backed up with appropriate details. Here are some highlights:

• SHS administration has focused on hiring dual-certified teachers

that fulfill more responsibilities, eliminating the need for hiring multiple teachers in some cases.
SHS administration has also devoted a lot of time to the new

Teacher/Leader Effectiveness program that is not only concentrated on evaluations, but mentoring and sharing of best practices.

• The SHS Ethics Forum--a student-led philosophy forum started

by Souhegan students and supported by the University of NH--won the Granite State award this year.

• A business partnership initiative instituted at SHS has given students access to internships, job shadowing, interview experience, and scholarship opportunities.

• SHS is as one of four schools in the nation creating a common student assessment, which is the PACE initiative. SHS was chosen due to the quality work the administration had done on Common Performance Assessments for teachers, and because of the respect our teachers have in the state for creating student assessments.

• PACE is one measure that will replace the NECAPs, which will no longer be administered and by all accounts was deeply flawed. That said, charges that SHS has never performed better than Hollis or Bedford on standardized testing is simply untrue. The latest NECAP scores on the DOE show that Amherst outperformed Bedford in writing, outperformed Hollis in reading, and was significantly better in all categories compared to state averages. Math had already been identified as an area needing improvement and a new math program was recently introduced.

• SHS has reduced their Cost Per Pupil (CPP) over the last couple of years, at a time when it was difficult for schools across the state to do so given the pressure of downshifted pension costs and skyrocketing health insurance premiums. At the same time, SHS enrollments actually went up by 4% and the overall SHS budget had a net decrease. Yes, lower costs and higher enrollment. Some would call that a win win.

• SHS increased teacher facing ratio (the number of students a teacher sees in any given trimester) from 67:1 to 82:1 since FY13. Student/teacher ratio increased from 9.1 to 10.7 during the same time period; 10.7 is the average student/teacher ratio for high school only districts, of which there are only three. I would hate to see these ratios go much higher.

• The Souhegan School Board has been meeting for more than two years to review their budget on a year-round basis. This year, they met every two weeks to review and analyze every aspect of their budget, how it compares to other districts, and whether/which other district's strategies would help SHS to reduce costs.

Recently, the board had a work session to make recommendations to the administration, based on this in-depth research. They brought forth creative ideas for 15 different areas that could represent short and long-term reductions to the overall budget, including a number of plans for future negotiations. This effort is not a direct knee jerk reaction to recent criticisms, but rather a measured response to continual community feedback and needs

I know my eagerness and faith have been renewed by speaking directly with the parties entrusted with using our money to best educate our kids. There are numerous positive things in the works and more on the way. I'm happy to devote time now to ensure our high school retains the unique approach that originally inspired me to move to Amherst so my current 4th grader can eventually attend SHS.

If you have questions, ask. Attend school board meetings. Get involved. Just don't lose sleep thinking our stewards are asleep at the wheel or clinging to the status quo. SHS is not spending without thought and has not lost the innovative spirit and passion on which it was founded.



Former Amherst Resident Promoted


